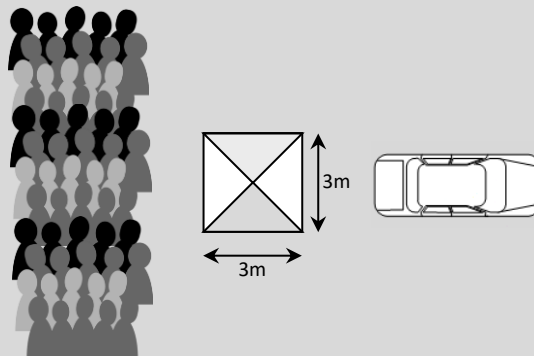

MARKET GUIDELINES

What we stand for.....

- As a VFMA accredited market, Bentleigh Farmers Market is a predominately fresh food and produce market that operates every 4th Saturday of the month (except January).
- We provide a suitable environment for Victorian farmers and associated producers to sell their farm origin product and/or associated value added primary products directly to the local community.
- It is not a market for resellers, repackaged produce, arts and crafts (unless of clear farm origin) or bric-a-brac.
- At least 90% of stallholders must be either accredited or approved members of the VFMA. No more than 10% of the considered total may be approved without being accredited.
- Bentleigh Farmers Market is professionally run by the School Council of East Bentleigh Primary School. Funds raised from running the market primarily go towards running the school's Stephanie Alexander Kitchen Garden program.

What you stand for....

- Have food you have grown, reared or fished yourself.
- Or have sourced fresh, predominately Victorian ingredients and processed them yourself
- Have a stall staffed by you or the people involved in the production.
- Have a commitment to attend both urban and regional accredited farmers markets.
- VFMA accredited or approved members.
- Keen to build strong community bonds through good food, cheery disposition and promoting best practise, high quality produce to valued customers.
- No plastic bags unless required to comply with health regulations.
- Upfront with clear prices on all items on your stall.
- Have requisite Food Preparation Permits.
- Have requisite Liability Insurance.

APPLICATION PROCESS

The Bentleigh Farmers Market reserves the right to decline this application, and/or not accept any products for sale at the Market that do not adhere to our Market Mix Policy.

If your application is accepted, you will be informed in writing together with an invoice for the first market stallholder fee. The stallholder fee for Bentleigh Farmers' Market is \$80 for a stall and (powered or unpowered). This fee includes the \$10 VFMA market day levy which pays for your membership to the association.
